In an effort to maximize the use of everyone's time and also provide you with a Spring ADA Committee compliance update, we will not have a called Spring meeting; instead we will do the following:

  - In lieu of a called Spring committee meeting, we will attend the upcoming May 5<sup>th</sup> Faculty/Staff Meeting to hear the report on the new Accessible Website, Accessible Resources, and the progress being made by the Accessible Technology and Information Committee. (You will recall that the formation of this committee was one of our initiatives from 2015-16.) I have included the email from Belinda Krigel, Chair of the Committee, below. “C”
- A. **Facilities/ Barriers Report-** Since our last meeting (November), there have been no student complaints about Facilities/Barriers. All student requests for facility related accommodations were fulfilled in a timely manner by our Maintenance/Facilities department. During Spring semester, we have received 2 community complaints about the women's upstairs restroom in the Sandridge Student Center not complying with ADA standards. Upcoming building renovations will address this area. - *Saralyn Mitchell*
- B. **Accessible Parking** - During Spring semester, a plan was coordinated for restriping the accessible parking by the Classroom Building, Waters, and the Gym to provide in compliance parking needed by our students and the community who are on campus. Our students attending classes have the greatest need for accessible parking by these buildings. A crosswalk will also be added for additional safety. This project is in process and will be completed May 2017. – *Jerry Bradford*

# What is accessible technology and information?

Technology and information are considered to be accessible if each can be accessed in more than one way without relying on a single sense or ability of the user.

Examples: Video - closed captioned, Audio – transcripts,  
Mousing – key strokes, Text on screen – screen reader  
Embedded graphics – Alt Text

# Why is accessibility important?

- Accessibility expands the world of information and learning for those with disabilities
- University services and classroom instruction use technology to create, communicate, and access information
- Past practices have been reactive, modifications done only when needed
- Today, technology and information is expected to be accessible

# The Goal

Make technology and information at Athens State accessible by the January 18, 2018 deadline for compliance with the Web Content Accessibility Guidelines (WCAG) 2.0, level AA standards, as adopted by the Section 508 refresh.

Meeting this goal will require gaining knowledge and implementing new technology while supporting our faculty and staff as they do the work required.
