Only students who are U.S. citizens or U.S. Permanent Residents and are currently classified as nonresident (“out-of-state”) for tuition purposes at Athens State University, and who believe additional information or changed circumstances could alter that classification should submit this application. Any student considering submitting this application should consult the University’s *Establishing Residency for Tuition Purposes* policy before completing and submitting this application.

A student seeking reclassification of residency for tuition purposes is responsible for sufficiently demonstrating that he or she has met the requirements as listed in the University’s *Establishing Residency for Tuition Purposes* policy. The burden of proof to justify any change in classification falls on the student seeking reclassification.

To apply for reclassification:

- Complete this application by answering all required questions; and
- Attach your typewritten personal statement explaining in detail why you believe you should be reclassified for tuition purposes; and
- Include **all documentary evidence** that supports the information in your personal statement and the responses to the questions in this application; and
- Affix **written signature** to the application; and
- Submit the application and all attachments to the Athens State University Office of the Registrar – Student Records:

 - **Note: Email submissions must originate from the applicant’s Athens State student email account**

For the purposes of the University’s *Establishing Residency for Tuition Purposes* policy, the classification “resident” has the meaning ascribed to it in the policy which may differ from the definition of the term “resident” used in contexts outside of the policy. Consequently, although a person may be considered a “resident” for local, state, federal, or other non-University purposes, the person still may not be classified as a “resident” for the purpose of tuition payment at Athens State University.

Please note: Only those students whose circumstances have changed in a significant way and are able to provide sufficient additional documentation for review will be considered for reclassification. Otherwise, no further reclassification requests will be considered.
