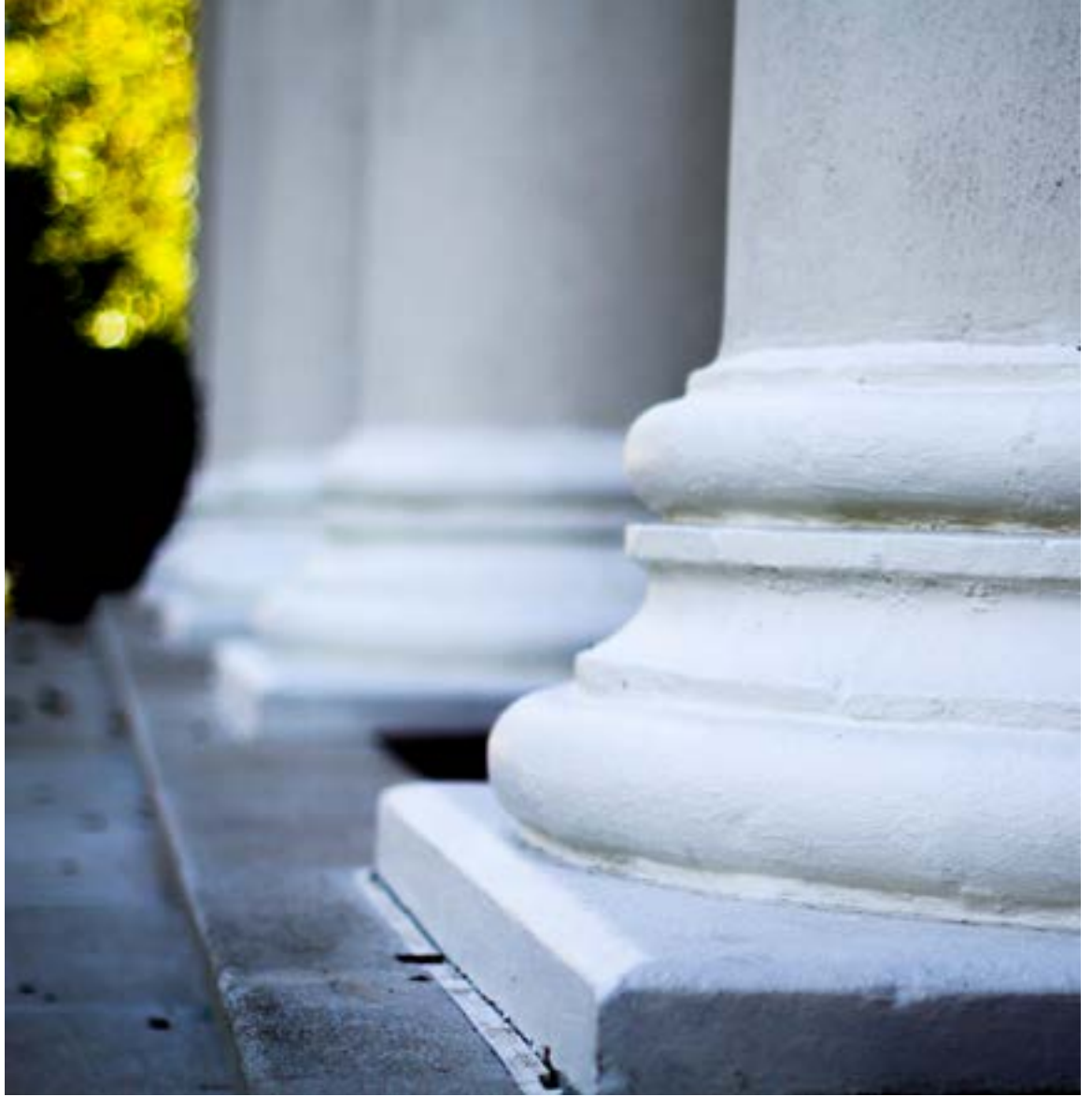

ATHENIANS CONTINUE TO BE RESILIENT


Dear Colleagues,

We continue to monitor the COVID-19 situation and are encouraged by the minimal numbers on campus. Thank you to all of the faculty, staff, and students for taking precautionary measures.

Similar to the protocols that were developed for spring semester, our summer campus guidelines focus on awareness, self-screening, vaccinations, limited class sizes, and social distancing. Data indicate that our approach has been very effective in controlling the spread and transmission of COVID-19. The use of masks and facial coverings is not mandated. Instead, individuals and groups have the responsibility to determine whether masking is needed based on infection rates, the scope for social distancing, and individual health and vaccination status. In all classrooms and group spaces, the expectations for wearing masks and facial coverings will be set by the faculty member or staff leader in charge, after discussion with the students and others involved.

CAMPUS SAFETY PRECAUTIONS

COVID-19 SELF-SCREENING

All University access points will continue to be open for campus entry. All faculty, staff, students, visitors, and contractors will be asked to conduct COVID-19 self-screening prior to entering campus.

COVID-19 SELF-SCREENING INSTRUCTIONS – FACULTY, STAFF, STUDENTS, CONTRACTORS & VISITORS

All faculty, staff, on-campus students, contractors, and visitors are expected to conduct a COVID-19 self-screen prior to entering campus each day.

- **Daily Symptom Checks** — Consider whether you are experiencing any symptoms associated with COVID-19:
 - Cough
 - Fever (100.4 degrees or above) or chills
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
- **Daily Exposure Checks** — Consider whether you have been in close contact with someone with confirmed COVID-19 in the last 14 days.

TAKE ACTION

IF YOU ARE EXPERIENCING SYMPTOMS OF COVID-19:

- Do not report to campus.
 - **EMPLOYEES:** Immediately notify your supervisor and the Office of Human Resources via phone or email (HR@athens.edu). With vice-presidential approval and a COVID-19 qualifying reason, an employee **MAY** be allowed to work from home if he or she can perform the essential functions of the job remotely.
 - **STUDENTS:** Immediately notify Student Services at StudentRTC@athens.edu and quarantine in accordance with CDC guidelines.
- If symptoms continue or progress, you should contact your healthcare provider for medical advice.



CAMPUS SAFETY PRECAUTIONS

COVID-19 SELF-SCREENING

IF YOU TEST POSITIVE FOR COVID-19:

VACCINATION STATUS	MANDATORY LEAVE	MASKING REQUIREMENTS
Everyone , regardless of vaccination status	*Isolate: Stay home a minimum of 5 days, if asymptomatic or symptoms are resolving (without fever for 24 hours). You should isolate longer if symptoms continue.	Wear a mask around others for an additional 5 days after you return to work.

IF YOU ARE EXPOSED TO SOMEONE WITH COVID-19:

VACCINATION STATUS	MANDATORY LEAVE	MASKING REQUIREMENTS

<ul style="list-style-type: none"> • Are Unvaccinated • Been Vaccinated twice with Pfizer or Moderna over 6 months ago or with J&J over 2 months ago (and not boosted) 	<p>*Quarantine: Stay home a minimum of 5 days.</p> <p>If symptoms develop, stay at home and get tested.</p>	<p>When you return to work, continue to wear a mask around others for an additional 5 days.</p> <p>Test on Day 5 if possible.</p>

***EMPLOYEES:** Immediately notify your supervisor and the Office of Human Resources via phone or email (HR@athens.edu). With vice-presidential approval and a COVID-19 qualifying reason, an employee **MAY** be allowed to work from home if he or she can perform the essential functions of the job remotely.

***STUDENTS:** Immediately notify Student Services at StudentRTC@athens.edu.



CAMPUS OPERATIONS

BUILDING PROTOCOLS

CLASSROOMS

- Classrooms will remain configured to reflect social distancing guidelines. Class enrollments are being monitored to provide for limited occupancy.
- Where practical, directional arrows will be used for ease of flow and distancing.
- Disinfectant supplies will be provided for all labs. Classrooms will be thoroughly cleaned daily, and disinfectant misters will be used in each classroom between class offerings.

HALLWAYS & STAIRWAYS

- All students, faculty, staff, and visitors are asked to walk to the right of the hallways to maintain one direction flow of traffic.
- Students are encouraged to wait outside or in vehicles until close to class time to prevent congestion in hallways before class. Students who do wait inside hallways and buildings should maintain six feet of physical separation or wear a face covering.

RESTROOMS

- The use of restrooms should be limited based on size to ensure at least six feet between individuals.
- Washing hands thoroughly after restroom usage will help prevent potential transmission of germs.

ELEVATORS

- Usage of campus elevators should be limited to one person at a time. If more than one individual must access an elevator, a face covering should be worn by all individuals.
- Hand sanitizer should be used immediately after using an elevator.

WORK AREAS, COMMON SPACES & MEETINGS

- Even though masks and facial coverings are not mandatory while on campus, we ask that everyone take account of the scope for social distancing and be respectful of others and their preferences.
- In all classrooms and group spaces, the expectations for wearing masks and facial coverings will be set by the faculty member or staff leader in charge, after discussion with the students and others involved.
- Employees should consider alternative approaches when activities require close interaction, such as using Zoom for meetings.

FACULTY OFFICE HOURS

- Faculty will continue normal office hours for summer semester 2022. Faculty are encouraged to meet with students virtually during regularly scheduled office hours. In circumstances that require in-person meetings, it is recommended that alternative areas are identified for such meetings that would allow for social distancing. Decisions relating to virtual office hours should be made in coordination with the Dean of each college.



ADDITIONAL CAMPUS SAFETY PRECAUTIONS

SOCIAL DISTANCING

- Social distancing is one of the best tools to avoid exposure to the COVID-19 virus and to help slow its spread. It is important to maintain at least six feet of separation from other students, faculty, and staff whenever possible.

PERSONAL PROTECTIVE EQUIPMENT

- All individuals, including those who are fully vaccinated, should consider wearing a mask in public indoor settings in areas of [substantial or high transmission](#).
- Individuals should consider wearing a mask regardless of the level of transmission, particularly if they are immunocompromised or at increased risk for severe disease from COVID-19, or if they have someone in their household who is immunocompromised, at [increased risk of severe disease](#), or not fully vaccinated.
- In all classrooms and group spaces, the expectations for wearing masks and facial coverings will be set by the faculty member or staff leader in charge, after discussion with the students and others involved.
- Reasonable accommodations may be allowed for individuals unable to meet any expected requirement by contacting our ADA officer, Dr. Rick Barth, for assistance at Rick.Barth@athens.edu or (256) 233-8176.

HANDWASHING & HAND SANITIZERS

- All employees and students should wash their hands often and for at least 20 seconds each time. If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol.
- Hand sanitizer stations have been strategically placed at multiple locations across campus for your convenience and safety.

ENHANCED CLEANING PROCEDURES

- ABM, the third-party vendor that provides janitorial services for Athens State, continues enhanced cleaning procedures with stringent cleaning and disinfecting protocols.

- A licensed professional counselor is available by appointment to discuss personal issues with currently-enrolled students and Athens State University faculty and staff on a brief-counseling basis.
- Counseling services are provided with confidentiality in mind through a partnership with the Mental Health Center of North Central Alabama and are offered at no charge to you.
- Personal counseling services can help you:
 - Learn how to relax during stressful times.
 - Learn coping skills to deal with anxiety, depression, addictions, grief, or other emotions that might interfere with your daily life.
 - Locate mental health services, resources, and support groups in your local community.
